

A word from Fr. Bill.....

Dear Parishioners:

Two months ago the name George Floyd did not mean anything to most of us. On March 25th, he died of asphyxiation while in police custody in Minneapolis. Now most of us are very familiar with his name. The manner of his death rightfully has caused anger, disgust, revulsion and many other feelings. It once again has surfaced the problem of racism in our society. Many have taken to the streets and have had peaceful demonstrations to heighten the awareness of the issue of racism and how it impacts the lives of so many people. Many organizations have done some self-searching to see how they contribute to the problem. Many organizations have made some changes in their approach to how they function.

In October of 2018, our United States Catholic Conference of Bishops wrote a pastoral letter entitled: "Open Wide Our Hearts: The Enduring Call to Love." Less than two years ago, in their pastoral letter our bishops challenged us to look at the reality of racism in our society and to change racial attitudes and acts of which many of us may not even be aware. Most of us are probably not even aware that the bishops wrote this pastoral letter. It certainly predated Mr. Floyd's death and the issue of racism which has surfaced since his death.

I was thinking if I and more people had reflected on the bishops' words, would Mr. Floyd's death perhaps been avoided? Maybe. Maybe not. But I have gone on to think that if I and others could be educated now in what the bishops said, it may lessen some racial attitudes and acts which are integrated into our lives, even unknowingly.

In that spirit, I am inviting parishioners to be part of a six-week reflection and discussion on the pastoral document of the bishops. It will be on Zoom on Monday evenings July 6 to August 10th, beginning at 7:00 PM and going no longer than 8:30 PM. The length of time will be affected by the number of participants. While it is preferable that each person is present each week, it certainly is not required. The first week, we will just introduce ourselves and become familiar with the process. The next four weeks, we will discuss each of the four chapters of the Pastoral Letter: What is Racism? Do Justice, Love Goodness, and Walk Humbly with God. The sixth week, we will have a conversation concerning if we want to do anything with what we have discussed. I will provide a copy of the document and some questions for discussion each week from a study guide on the document.

Why am I suggesting we as a parish do this? I presented this to our Parish Pastoral Council on June 17th and said that since the issue of racism has been heightened in recent months, we as Church and parish should be more educated about its reality, its implications and look at practical ways we might respond to this moral issue.

VIISTA Scholarship Program

BECOME AN IMMIGRANT ADVOCATE

WHAT IS THIS SCHOLARSHIP?

A.D.R.O.P., through support by the Augustinian Province of St. Thomas of Villanova, is offering scholarships for students to enroll in VIISTA, Villanova University's new 100% online certificate program to train immigrant advocates for justice. Learn more about VIISTA here.

To qualify for the scholarship, students must be supported by a not-for-profit organization that is Department of Justice (DOJ) recognized or willing to apply for DOJ recognition, and willing to provide employment to the scholar winner post-graduation. WHAT DOES THE SCHOLARSHIP COVER?

The VIISTA Program is comprised of 3 consecutive Modules, each of which consists of 2 x 7-week Sessions. The tuition cost of the entire 3-Module Program is \$3,810. The tuition for each Module is \$1,270.

Scholarships:

- 75% tuition scholarship for Module 1, Certificate in Immigrant Accompaniment – scholar or employer would pay only \$318 tuition
- 75% tuition scholarship for Module 2, Certificate in Immigrant Advocacy (could be eligible to apply to become a DOJ partially accredited representative) – scholar or employer would pay only \$318 tuition
- 100% tuition scholarship for Module 3, Certificate in Immigration Trial Advocacy (could be eligible to apply to become a DOJ fully accredited representative)

WHAT WILL I NEED FOR THE APPLICATION?

- Application – name, contact info, name of organization sponsoring you, brief description of educational and/or experiential background
- Letter of interest – why do you want to become involved in VIISTA and train to become an immigrant advocate? (at least 250 words)
- Letter of support signed by Executive Director of the not for profit organization supporting migrants and/or refugees, that is DOJ recognized or willing to apply for DOJ recognition, and is offering employment or volunteer opportunities or effort to support employment post-graduation
- Resume
- Agreement – will dedicate 10-15 hours/week of study and will work as immigrant advocate for at least 3 years (6 years part time) after graduation. Signed by non-profit.
